I represent that I am in good physical condition and emotional health, and I am capable of participating in the activity without accommodation.

I UNDERSTAND THAT THIS RELEASE WILL REMAIN IN EFFECT AT ALL TIMES WHILE I PARTICIPATE IN THE TREE PLANTING/WATERING ACTIVITY DURING THIS YEAR'S PROGRAM.
